EXECUTIVE ORDER NO. 04 SERIES OF 2022

AN EXECUTIVE ORDER CONSTITUTING THE MEMBERS OF THE EDITORIAL TEAM OF THE MUNICIPAL PUBLICATION "ANG TRINIDAD" FOR THE PURPOSE OF PUBLISHING THE SECOND ISSUE AND SETTING THE AMOUNT FOR THE PUBLICATION, THE HONORARIA OF THE MEMBERS OF THE EDITORIAL TEAM AND OTHER EXPENSES FROM THE ALLOCATED BUDGET

WHEREAS, Municipality of Trinidad launched the maiden issue of "Ang Trinidad" last June 2020;

WHEREAS, due the COVID-19 Pandemic and the onslaught of Super Typhoon Odette last December of 2021, the Municipality is yet to publish the second issue of said Municipal Publication;

WHEREAS, the COVID-19 Pandemic having been more or less already contained coupled with the fact that the Municipality had already recovered from the effects of the Super Typhoon, it is already high-time to launch the second issue of "Ang Trinidad";

NOW THEREFORE, I, ATTY. ROBERTO C. CAJES, Ph.D., Local Chief Executive of the Municipality of Trinidad, Province of Bohol, by virtue of the power vested in me by law, do hereby ORDER the following, to wit:

Section 1. The Publication of the Second Issue of "Ang Trinidad".

The publication of the second issue of "Ang Trinidad" shall be released for distribution at two thousand five hundred (2,500) copies to the constituents of the Municipality on the month January 2023. The size of the paper shall be the same as the first, specifically at 17 inches tall and 11 inches wide and consisting of sixteen (16) pages.

Section 2. Full Editorial Freedom and the Members of the Editorial Team for the Publication of the Second Issue of "Ang Trinidad".

The Editorial Team shall have full editorial freedom as long as the articles are not contrary to law, public order, public morals, public policy and does not deal with confidential and sensitive matters concerning local government functions and activities.

Section 3. Allocated Budget.

The Municipal Publication has an allocated budget of Two Hundred Twenty Thousand Pesos (Php 225,000.00) in the 2022 Municipal Budget. As such, the cost of publication at 2,500 copies, the honoraria of the members of the Editorial Team and other expenses in the preparation, distribution, assessment activities and other necessary and related expenses shall be sourced out from the said allocated budget.

Section 4. Setting the Amount of Honoraria to the Members of the Editorial Team.

Each of the members of the Editorial Team shall be entitled to honorarium in the following amounts but not to exceed twenty five percent (25%) of the basic salary of the member concerned in accordance with existing rules and regulations. Should the amount set herein exceeds the 25% limit, the concerned member shall only be entitled to the said 25%.

a. For the Editor-in-Chief	P7,000.00 honorarium plus P1,000 per article as written and published
b. For the Adviser	P6,000.00 honorarium plus P1,000 per article as written and published
c. For Associate Editors	P5,000.00 honorarium plus P1,000 per article as written and published
d. For the Proof Readers	P4,000.00 honorarium plus P1,000 per article as written and published
e. For the Writers	P3,000.00 honorarium plus P1,000 per article as written and published
f. For the Photo Journalist	P5,000.00 honorarium
g. For the Layout & Styling Artists	P5,000.00 honorarium

Section 5. Other Expenses.

The balance of the allocated budget shall be used to defray the cost of publication, preparation, distribution, assessment activities and other necessary and related expenses.

Section 6. Separability Clause.

In any event that any provisions of this Order or any part hereof is declared invalid, contrary to law or unconstitutional, the provisions not hereby affected shall remain in force and effect;

Section 7. Repealing Clause.

All Executive Orders and Issuances inconsistent with the provisions of this Executive Order are hereby repealed or amended accordingly.

Section 8. Effectivity.

This Order shall take effect immediately upon signing.

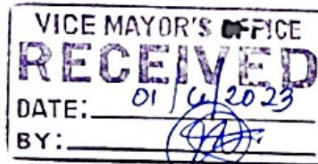
