"AN ORDER AMENDING EXECUTIVE ORDER NO. 37 SERIES OF 2022, SECTION 1 THE NEW COMPOSITION OF MEMBERS OF THE MUNICIPAL COUNCIL FOR THE PROTECTION OF CHILDREN (MCPC) OF THE MUNICIPALITY OF TRINIDAD, BOHOL"

WHEREAS, pursuant to the Department of the Interior and Local Government (DILG) Memorandum Circular No. 02-121, s.2002, LGUs are encouraged to organized their respective LCPC as per provision to PD 603 as amended and RA 8980;

NOW, THEREFORE, I, Atty. ROBERTO C. CAJES, Ph.D., Municipal Mayor of the Municipality of Trinidad, Bohol, by virtue of the powers vested in me by the Local Government Code and the law, do hereby order and direct the following:

Section 2. Duties and Functions of MCPC shall have the following duties and functions:

(a) Formulate plans and policies for the children that are gender-fair, culturally relevant and responsive to the needs of diverse groups of children from 0 to 12 years of age;

(b) Prepare AWFP for the children and recommended appropriation to the Sangguniang Bayan;

(c) Provide coordinative linkages with other agencies and institutions in the planning, monitoring and evaluation of plans for children;

(d) Provide Technical assistance and recommend financial support to the Barangay

Council for the Protection of children;

(e) Establish and maintain database on children in the municipality;

(f) Foster education of every child;

(g) Advocate for the establishment and maintenance of playgrounds, day care centers and other facilities necessary for child and youth development;

(h) Recommend local legislators promoting child survival, protection, participation and development especially on the quality of television shows, media prints and coverage, which are detrimental to children and with appropriate funding report;

(i) Assist children in need of special protection and refer cases filed against child abuses

to proper agencies/institutions;

(j) Conduct capability building programs to enhance knowledge and skills in handling children's program;

(k) Monitor and evaluate the implementation of the program and submit quarterly status report to MCPC; and

(1) Perform such other functions as provided for the ECCD and other child related law.

Section 3. Meetings and Quorums.

(a) Conduct a regular quarterly meetings and special meetings when necessary; and

(b) Meeting shall be supported by minutes of the meetings.

Section 4. Repealing Clause. - All prior issuances on the organization and functions of the Municipal Council for the Protection of Children inconsistent herewith shall be deemed superseded by this Order.

Section 5. Effectivity. This Executive order shall take effect immediately.
