"AN ORDER REITERATING SECTION 22(c) OF REPUBLIC ACT NO. 10742, OTHERWISE KNOWN AS THE SANGGUNIANG KABATAAN REFORM ACT OF 2015, AND DIRECTING SANGGUNIANG KABATAAN FEDERATED PRESIDENT OF THE LOCAL GOVERNMENT UNIT OF TRINIDAD, BOHOL AS EX OFFICIO MEMBER OF THE LOCAL SCHOOL BOARD, THE LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN, THE LOCAL DEVELOPMENT COUNCIL, THE LOCAL HEALTH BOARD, LOCAL TOURISM COUNCIL AND THE LOCAL PEACE AND ORDER COUNCIL"

WHEREAS, Section 13 of the Philippine Constitution provides that: "the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being. It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs";

WHEREAS, Section 22(cc) of Republic Act No. 10472, otherwise known as the Sangguinang Kabataan (SK) Reform Act of 2015, provides that the duly elected President of the Pederasyon ng Sangguniang Kabataan (SK) shall serve as ex officio member of the Local School Board, the Local Council for the Protection of Children, the Local Development Council, the Local Health Board, the Local Tourism Council, and the Local Peace and Order Council;

WHEREAS, to observe the said provision and recognize the state responsibility to enable the Sangguiang Kabataan Federated President fulfill his/her vital role in nation building;

NOW, THEREFORE, I, Atty. ROBERTO C. CAJES, Ph.D., Mayor, Municipality of Trinidad, Bohol, by virtue of the powers vested in me by law, do hereby order the Sangguniang Kabataaan Federated President of the Municipality of Trinidad, Bohol as ex officio member of the Local School Board, the Local Council for the Protection of Children, the Local Development Council, the Local Health Board, Local Tourism and Local Peace and Order Council:

Section 1. Repealing Clause. All other orders, and issuances which are inconsistent with this Executive Order are hereby repealed or modified accordingly.

Section 2. Effectivity

This order takes effect immediately upon issuance of the order. Let the copies of this order be furnished to the Sangguniang Bayan, Sangguniang Kabataan Federated President, MPDC, MLGOO and others concerned for their information.
