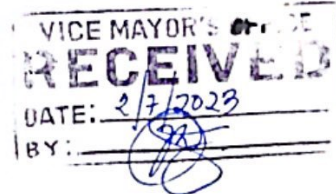

"AN ORDER CREATING THE TECHNICAL WORKING GROUP FOR THE REVISION OF THE COMPREHENSIVE ECOLOGICAL SOLID WASTE MANAGEMENT ORDINANCE (MO NO. 07 SERIES OF 2012) OF THE MUNICIPALITY OF TRINIDAD, BOHOL"

WHEREAS, it is a declared State policy to adopt a systematic and comprehensive Ecological Solid Waste Management Program to ensure the protection of the public health and environment;

WHEREAS, new development and trends in the field of solid waste management has cropped up with the advent of single-use plastics which contributed greatly to environmental destruction and degradation;

WHEREAS, Municipal Ordinance No. 07, series of 2012, titled A Comprehensive Ecological Solid Waste Management Program needs to be strengthened in order to respond to present situation and realities;

WHEREAS, in the interest of service and in keeping with its mandate under Republic Act 9003 otherwise known as Ecological Solid Waste Management Act of 2000, a Technical Working Group (TWG) is hereby created for amendment of Municipal Ordinance No. 07, series of 2012;

NOW, THEREFORE, I, ATTY. ROBERTO C. CAJES, Ph.D., Local Chief Executive of LGU-Trinidad, Bohol, by virtue of the powers vested in me by the Local Government Code of 1991 and other laws, do hereby order and direct the following:

Section 2. The TWG shall have its tasks and functions but not limited to the following:

1. Draft the proposed amendment of the Ecological Solid Waste Management Ordinance;
2. Identify provision/s of the previous ordinance that needs to be amended;
3. Conduct meetings and activities required and necessary in amending the ordinance;
4. Submit progress report to the LCE in relation to their tasks; and,
5. Present the draft amended ordinance to the Sangguniang Bayan for approval.

Section 3. The Secretariat shall have the following functions:

1. Assist in the drafting of amendment of the Ecological Solid Waste Management Ordinance;
2. Make schedule of activities relevant to the amendment;
3. Assist in the conduct of activities and preparation of necessary documents; and,
4. Assist in coordinating the schedule of activities.

Section 4. Timeframe. The TWG is hereby given two (2) months to finish its tasks of drafting an amended Ecological Solid Waste Management Ordinance.

Section 5. Funds. The expenses to be incurred in the conduct of activities related to the performance of the functions and assigned tasks shall be charged against the funds allocated to ESWM in accordance with the existing government accounting and auditing rules and regulations.

Section 6. Effectivity. This Executive Order shall take effect immediately upon signing.
