**"AN ORDER CREATING THE PUBLIC PRIVATE PARTNERSHIP SELECTION COMMITTEE IN THE MUNICIPALITY OF TRINIDAD, BOHOL"**

WHEREAS, Section 20, Article II of the 1987 Philippine Constitution provides that the state recognizes the indispensable role of the private sector, encourages private enterprise, and provides incentives to needed investments;

WHEREAS, Section 3 (1), of RA 7160 known as the "Local Government Code of 1991", the participation of the private sector in local governance, particularly in the delivery of basic services, shall be encouraged to ensure the vitality of local autonomy as an alternative strategy for sustainable development;

WHEREAS, Municipal Ordinance No. 17 series of 2020 provides guidelines in pursuing the Public-Private Partnership (PPP) under the BOT scheme and other contractual arrangements towards good governance, providing for the procedure for selecting the private sector proponent, adopting a contract management framework, and providing appropriations, incentives and for other purposes;

WHEREAS, Section 14 of the Municipal Ordinance No. 17 series of 2022 stated the Public-Private Partnership Selection Committee shall be constituted and convened by the Local Chief Executive;

NOW, THEREFORE, I, **Atty. ROBERTO C. CAJES, Ph.D.**, Municipal Mayor of the Municipality of Trinidad, Bohol by the powers vested in me by law, I do hereby order the following.

**Section 1. Creation of Public-Private Partnership Selection Committee:** The composition shall be the following:

**Section 2. Duties and functions of PPP Selection Committee.**

Shall be responsible for all aspects of the pre-selection and selection process, including among others, the representation of the feasibility or project study and selection/tender documents, determination of the minimum designs, performance standards/specifications, economic parameters and reasonable rate of return or tariff-setting mechanism appropriate to the PUBLIC-PRIVATE PARTNERSHIP (PPP) Modality; drafting or evaluation of the PUBLIC-PRIVATE PARTNERSHIP (PPP) contract; publication of the invitation to apply for eligibility and submission of proposals or comparative proposals, defining the eligibility requirements, appropriate form and amount of proposal securities, and schedules of the selection and challenge processes;

Pre-qualification of PSPs, bidder or challengers conduct of pre-selection conferences and issuance of notices; interpretation of the rules regarding the selection process; conduct of the selection or challenge process; evaluation financial and technical aspects of proposals resolution of disputes between PSPs and challengers; defining the appeals mechanisms; and recommendation for the acceptance of the proposals and/ or the award of the contract.

**Section 3. Repealing Clause.** All orders issued inconsistent with this order shall hereby repealed and modify accordingly.

**Section 4. Effectivity.** This order shall take effect immediately. Let this copy furnished to Sangguniang Bayan, MTO, MPDC, MBO, MEO, TWSMB, Municipal Accountant and MHO for compliance and information.
