EXECUTIVE ORDER NO. 23 Series of 2023

"AN ORDER RECONSTITUTING THE MUNICIPAL INTER-AGENCY COMMITTEE (MIAC) IN ORDER TO PROVIDE TECHNICAL SUPPORT TO KALAHI-CIDSS NCDDP-AF PROJECT IN THE MUNICIPALITY OF TRINIDAD, BOHOL"

WHEREAS, the Department of Social Welfare and Development and the Municipality of Trinidad have entered into a General Memorandum of Agreement for the purpose of continuing the development and implementation of social protection programs under the KALAHI-CIDSS-NCDDP-AF that would further address the needs of Trinidad, Bohol poor, empower its citizen's and promote inclusive growth municipality-wide;

WHEREAS, the Local Government Unit of Trinidad, Bohol through the present administration expresses appreciativeness to the DSWD for the municipality inclusion in the KALAHI-CIDSS-NCDDP-AF PROJECT;

WHEREAS, the foregoing project aims to reduce poverty and empower the communities through active and enhanced participation in the different implementation cycles of the project through community voluntarism;

WHEREAS, in the selection of the sub-projects for the KALAHI-CIDSS-NCDDP-AF the community volunteer shall determine through the active participatory ranking of priority needs of the community;

WHEREAS, the Local Government Unit of Trinidad, Bohol is mandated to provide technical support and assistance to KC-NCDDP-AF implementation;

NOW, THEREFORE, I, Atty. ROBERTO C. CAJES, Ph.D., Municipal Mayor of the Municipality of Trinidad, Bohol, by virtue of the powers vested in me by the Local Government Code and the law, do hereby order and direct the following:

Section 3. DUTIES AND FUNCTIONS. The Municipal Inter-Agency Committee shall perform the following:

a. Facilitate the implementation of the KC-NCDDP-AF;

 Facilitate the involvement of the municipal stakeholders and promote convergence of programs and interventions;

 Initiate institutionalization of the community-driven development process of the KC-NCDDP-AF in the municipality and barangays;

d. Facilitate the inclusion of the KC-NCDDP-AF Project in the Barangay Development Plan and Municipal Development Plan;

e. Monitor the implementation of the KC-NCDDP-AF programs once in a mouth as the need arises:

f. Monitor the operation and maintenance committees of the implementation of the KC-NCDDP-AF program in the barangays and ensure their sustainability once a month or as the need arises; and

 g. Conduct a regular monthly meeting for reporting, updating, problem-solving, and project assessment.

Section 4. Effectivity. This Executive order shall take effect immediately. Any existing order found inconsistent thereto shall be deemed repealed or modified.
