Series of 2023

"AN ORDER RECONSTITUTING AND REORGANIZING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC) OF THE MUNICIPALITY OF TRINIDAD, BOHOL"

WHEREAS, Republic Act no. 10121 otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010 supersedes Presidential Decree 1566 otherwise known as Philippine Disaster Control, Capability and Preparedness Program, thus paving the way to rename the Municipal Disaster Coordinating Council into the Municipal Disaster Risk Reduction and Management Council;

WHEREAS, RA 10121 upholds people's rights to life and properly and adheres to internationally accepted principles, norms, and standards in disaster risk reduction management and humanitarian assistance;

WHEREAS, the same adopts a holistic, comprehensive, integrated, proactive, and multi-sector approach in addressing the impacts of disaster and climate change;

WHEREAS, pursuant to RA 10121, the Local Government Unit of Trinidad is mandated to develop, promote and implement a comprehensive Local Disaster Risk Management Plan engaging the participation of non-government organizations, the private sector, and volunteers in disaster risk reduction;

WHEREAS, the Geohazards Mapping Team of the Mines and Geosciences Bureau of DENR Regional Office VII based in Mandaue City has identified twelve (12) barangays out of 20 to be landslide susceptible and nine (9) out of the twenty (20) barangays to be flooding susceptible areas respectively in its geohazards assessment conducted last September 21-22, 2007 thus, making the creation of the local disaster risk reduction management body/council indispensable;

WHEREAS, there is a need to reconstitute and amend the membership of the Municipal Disaster Risk Reduction and Management Council to pave the way for the new administration for the continuity of DRRM plans, activities, and programs;

NOW, THEREFORE, I, Atty. ROBERTO C. CAJES, Local Chief Executive, Local Government Unit of Trinidad, Bohol, by virtue of the power vested in me by law, hereby orders the reorganization of Municipal Disaster Risk Reduction and Management Council (MDRRMC) of the Municipality of Trinidad, Bohol.

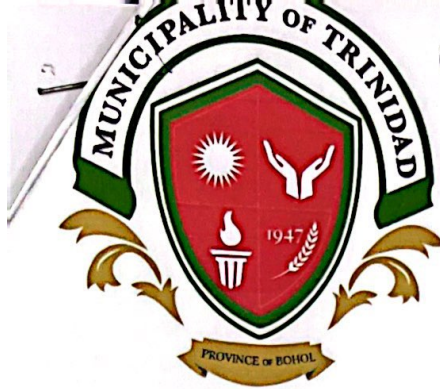

Section 2. Functions and Responsibilities.

- a) Coordinating and monitoring the implementation of disaster risk reduction and management activities as per the Local Disaster Risk Reduction and Management Plan.
- b) Ensure the implementation of the Local Disaster Risk Reduction and Management Plan. Coordinate and monitor all disaster risk reduction and management activities.
- c) Coordinate and monitor the implementation of the disaster risk reduction and management program through community participation and public awareness campaigns.
- d) MDRRMC work in close collaboration with the Mauritius Meteorological Services which shall develop and improve warnings and advisory systems for all natural hazards affecting Mauritius.

- e) MDRRMC supports barangays in building capacity for disaster risk reduction and management.
- f) MDRRMC facilitates and coordinates the conduct of regular training, drills, and simulation exercises to test the adequacy of disaster response plans.
- g) MDRRMC undertakes and participates in post-disaster reviews including lessons drawn from previous disasters in disaster preparedness and response plans.
- h) MDRRMC shall assist relevant stakeholders to develop an appropriate risk transfer mechanism for post-disaster recovery and rehabilitation purposes.
- i) Collaborate with all relevant stakeholders so that disaster risk reduction and management becomes an integral objective of environment-related policies and plans, sound land use planning, natural resources management, education and social development plans, economic and sectoral policies as well as infrastructure through enforcement of building codes.
- j) Foster regional and international cooperation in disaster risk reduction management issues, including best practices and sharing of expertise.
- k) Promote research and development and commission studies on disaster risk reduction and management matters.
- l) Disseminate information concerning disaster risk reduction and management.

Section 3. Meetings

The MDRRMC shall meet and convene at least once every three (3) months or as needed as may necessary.

Section 4. Repealing Clause

Any order is inconsistent hereof shall be deemed repealed and modified.


Section 5. Effectivity

This Executive order shall take effect immediately.
