"AN EXECUTIVE ORDER RECONSTITUTING THE FAMILY DEVELOPMENT SESSION (FDS) TEAM AND THE MUNICIPAL CONVERGENCE COMMITTEE (MCC) IN THE MUNICIPALITY OF TRINIDAD, BOHOL"

WHEREAS, as mandated in the 1987 Philippines Constitution and other laws, the state recognizes the sanctity of family life, protects its members from all forms of abuse, neglect, cruelty, discrimination, and conditions prejudicial to their development, and strengthens its solidarity to ensure total development;

WHEREAS, the Pantawid Pamilyang Pilipino Program- a poverty alleviation intervention of the National Government is one of the responses of the Philippine Government to the challenge of meeting the Sustainable Development Goals (SDGs);

WHEREAS, in the implementation of the Pantawid Pamilyang Programs, the development of family is seen to be very important to give protection and nurturance as well as respond to the growth and educational development of young members of the household;

WHEREAS, the Family Development Session (FDS) is deemed an important intervention to fulfill the family development thrust of the programs as well as fulfillment of investing in the human capital of families and children 0-18 years old;

WHEREAS, Family Development Session (FDS) both serves to strengthen the capabilities of family members particularly the parents to become more responsive to the needs of the family and children and enables the households to become socially aware and be involved in community development activities;

Section 2. Duties and Function of the Family Development Session Team

1. Plan and organize the overall conduct of the Family Development session in the total covered household areas.

2. Coordinate with the parent leader in the conduct of preparatory activities.

3. Assist in the organization of 25-30 household beneficiaries to form a group in the neighborhood.

4. Facilitate the conduct of Family Development Sessions and/ or serve as a resource person with the assistance of LGU Links, CSOs, and parents Leaders.

5. Prepare the needed materials and visual aids in the conduct of FDS.

6. Provide other support services to household beneficiaries in coordination with the FDS team and Barangay Local Government

7. Follow-up/conduct home visits to households with problems such as vices, abuse, misuse of grants, and non-compliance to conditions, and refer to MSWDO, SWO III, and SWAD team leader for counseling and appropriate interventions.

8. Comply with the documentation and schedule of submission.

Hold a regular meeting.

Section 3. Effectivity. This order shall be effective immediately and will remain to be in full force and effect until revoked and amended.
