**EXECUTIVE ORDER NO. 46

**“REORGANIZATION OF THE MUNICIPAL PLANNING TEAM FOR THE LOCAL INVESTMENT PLAN FOR HEALTH (LIPH) OF THE MUNICIPALITY OF TRINIDAD, BOHOL”**

**WHEREAS**, the Republic Act 11223 otherwise known as the Universal Health Care Act of 2019 and its Implementing Rules and Regulations stated that the National Government shall have available commensurate financial and non-financial grants, including capital outlay, human resources for health and health commodities in accordance with the approved province-wide and city/municipal-wide health investment plans;

**WHEREAS**, in pursuant to the Regional Memorandum No. 027-2016 guidelines for the Utilization of Local Investment Plan for Health (LIPH) in all DOH assistance to Local Government Unit (LGU);

**WHEREAS**, Administrative Order No. 2020-0022 (VI) (A) mandated the LGU to organize the LGU Planning Team to ensure the development, implementation, monitoring, and evaluation of the Local Investment Plan for Health (LIPH);

**NOW, THEREFORE, I, Atty. ROBERTO C. CAJES, Ph.D.**, Local Chief Executive, Local Government Unit of Trinidad, Bohol, by virtue of the powers vested in me by the Local Government Code and the law, do at this moment order and direct the following:

**Section 1. Organization of the Municipal Planning Team for Local Investment Plan for Health.** - The composition is as follows

**Section 2. Function and Responsibilities of the MPT.** — The MPT shall exercise the following:

- Organize/ mobilize planning team;
- Provide technical assistance to the barangays;
- Include lower level ( barangay health station ) in LIPH/AOP;
- Develop municipal LIPH/AOP;
- Present to the LHB for approval and creation of resolution supporting the planning; and
- Implement, fund, and monitor LIPH/AOP.


**Section 3. Schedule of Planning/Meetings.**

**Section 5. Effectivity.** This Executive order shall take effect immediately.
